



Document 4: Instructions to Tenderers

1. Closing date and time for submission of tenders:

Sep 18, 2024 at Time 4:00 PM Hrs.

2. Submission of tenders

House#01, Street#01, Sector#2, Dan-e-Nal, Bagh-e- Bala, Kabul-Afghanistan.

3. Timetable for provision

To be submitted by the bidder

4. Language of offers

All tender's documents are to be submitted in English

5. Lot Wise

Bidders must apply for the whole Lot Items. Otherwise, Union Aid (UA) reserves the right to reject the offer.

6. Period of validity of offers

All bids must be valid for a minimum of sixty days from the tender submission date.

7. Currency

Afghani

8. Terms

The prices must be inclusive of all taxes, delivery / transportation, loading / unloading / installation and allied costs up to the point of delivery.

The Logistic agency must quote only one option for each item. Bids received with more than one options and rates may be rejected.

Logistic agency must not be engaged in any corrupt, fraudulent, collusive or coercive practices including but not limited to applying/ bidding by multiple names / companies. If any bidder is found to be involved in such practices his/her bid may be rejected and the companies in question permanently black listed

9. Type of contract

Logistic agreement

10. Tender guarantee

A tender guarantee of 5% of the bid submitted must accompany the bid in shape of a bid security; favoring "Union Aid". Bids received without Tender Guarantee must be rejected. If the selected bidder refuses to sign the Logistic contract, then Union Aid reserves the right to forfeit the bid security. Once the contract has been awarded to successful bidder his/her bid security will be converted into performance guarantee. If any selected bidder refuses to accept the order for the offered lot/lots or refuses to sign the contract, Union Aid reserves the right to forfeit the bid security of the bidder.

13. Evaluation of tenders

The awarding will be fulfilled by the supplier/Company and Client (Union Aid), based on the following criteria (Refer to tender pack document number 2 for evaluation criteria)

- b. Tax Clearance Evidence
- c. Update License
- d. Company Bank Account Details
- e. Annual Turnover
- f. Relevant Experience
- g. Delivery Period
- h. Quality Based on the sample check
- i. 5% Bid Security

14. Cancellation of the tender procedure

15. Appeals Process
